

# LONG-TERM CARE INSURANCE INFORMATION & SEMINAR

In 2011, the City of New York ended an arrangement with MetLife that had given city employees the ability to purchase long term care insurance. Those who previously enrolled in the MetLife plan are still covered. However, employees will now have to look elsewhere for LTC insurance.
