## Medicare Disadvantage


In addition, insurance companies can set up their own Medicare plans, called Medicare Advantage, in which people pay their Medicare tax to the private companies instead of to the government. To promote this sub-division of Medicare, the government paid the insurance companies a bonus of 19 percent more than they paid for regular Medicare coverage.

To get people to switch over, the insurance companies offered little bonuses in their coverage, such as eyeglasses and maybe a little dental work. They were able to do this because the government was subsidizing the expenditures.

The Medicare Advantage programs have become very popular, especially among minority groups, and now just under a fifth of Medicare recipients have signed up with them and the numbers are growing rapidly. However, the competitive insurance companies have gone all out to sign up new members and abuses have been reported in several states.

So what we have is an extra layer

of private companies taking more than their share of the costs of the medical coverage. The Humana company, which has 3.5 million people on its Medicare drug coverage plan and a million more on its Medicare Advantage plan, recently reported that its profit has more than doubled in the last quarter.

Where does all this private profit come from? It comes from those of us who are on the regular Medicare plan. It is estimated that regular Medicare subscribers pay \$2 a month extra so that the private insurance companies can get the special 19 percent subsidy from the government.

So why don't we just join a Medicare Advantage plan and also reap whatever little extras there are? Because it is wrong. It is wrong for our government to give these subsidies. This is the United States of America, famous for one person one vote, and everybody on Medicare should be treated equally.

Have the insurance companies in this country become so powerful through their donations to politicians that they can gouge out extra profits from you and me without our having a say in it? The Republicans make no bones about their first loyalty going to the corporations that have treated them so royally. But how about the so-called new Democratic majority that was supposed to right all these wrongs that have been perpetrated on us the past six years?

Congress should eliminate the 19 percent subsidy they have given the insurance companies. Those
