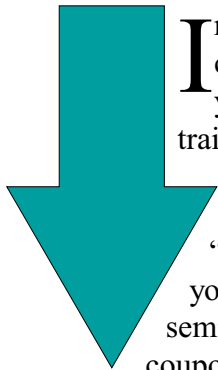


ONE BIG COUPON

FALL 2019 SEMINARS AND CLASSES

Pre-Retirement Seminar – (A-L) Wednesday, October 2 • (M-Z) Wednesday, October 16

A single session seminar provides a review of the financial aspects of retirement, including pensions, welfare fund benefits, terminal leave, and medical benefits. Two sections will be offered, with enrollment based on the first letter of your last name. Be sure to indicate which pension tier you are part of on the other side of this form.

Basic Math – Two Wednesdays, October 23 • October 30

A two session refresher course on all of the basics of math, from addition and multiplication to decimals and fractions. We'll also cover graphs and word problems.

Introduction To Public Speaking – Three Mondays, October 7, October 21 and October 28

A three session course on the art of public speaking to help you to become a more proficient public speaker.

The Wonderful World of Civil Service – Thursday, October 10

A single session seminar guides you through civil service exams, lists, promotions, the “1 in 3 rule,” DP72 forms – and other fun (and essential) stuff.

The Joy of Statistics – Two Tuesdays, October 15 • October 22

An overview of basic statistical concepts in two sessions.

Pensions 101 – (A-L) Thursday, October 3 • (M-Z) Thursday, October 17

A one session seminar on the basics of the Tier 4 and 6 pension plans for city workers. If you are new to the pension system or have questions about how the system works, this is the seminar for you. Two sections will be offered, based on the first letter of your last name. Be sure to indicate your pension tier on the front of this form.

Intro to OSA's Welfare Fund Benefits – Thursday, October 24

A one-session overview of OSA's Welfare Fund benefits (vision, dental, insurance, etc.) and supplementary voluntary benefits (short term disability insurance, voluntary life insurance), introduced by the staff members who make them happen.

Due Process, Grievances and Disciplinary Procedures – Tuesday, October 29

A single session overview of your rights as a union member. Topics to include due process rights, contractual grievances, and disciplinary procedures.

Paid Family Leave: What It Covers & How To Apply – Friday, October 4

As of July, 2019, OSA members qualify for and can apply for paid family leave benefits which cover three situations: to bond with a child, to care for a family member, or to assist loved ones when a spouse, domestic partner, child or parent is deployed abroad on active military service. This seminar will provide an overview of the program, what it covers and how you can apply.

Overview: Supplemental Insurance Available Through OSA – Thursday, October 31

Representatives of the Voluntary Insurance Program will present information on a variety of voluntary supplemental benefits available to OSA members, including life insurance, short term disability, legal assistance and supplemental health insurance (critical illness and personal accident insurance)
